

Life Academy Home Educator's Contract

I, the undersigned, understand that home education through Life Academy depends heavily upon a trust relationship being established between the school and the home educating family. Honesty is the key factor. Therefore, I affirm that all answers on all paperwork and in the interview are complete and accurate. I have disclosed all relevant and pertinent information, and have not sought to hide information which might indicate home educating is not in the best interest of me or my children.

I acknowledge that I will comply with the policies of the school, as outlined in the interview and published in the handbook. Future policy changes will be provided to me in writing, at which time I agree to abide by them or secure other enrollment.

I am the parent or legal guardian of the child(ren) being enrolled and I have the legal standing to make educational decisions for them.

I affirm that I have given careful and due consideration to the decision to home school, and have not entered into this decision with haste. I understand that I, along with the other parent or guardian, am assuming sole responsibility for the education of said children, even the portions which may be delegated to another person.

I am committing to home educate my child for a period of time no less than the current school year. I commit to providing adequate learning materials and opportunities for them. I will exercise diligence in teaching the children in a responsible way. I understand that social, moral, and academic issues are equally important, and will seek to find a balance. I will make whatever personal sacrifices are necessary to help my child thrive and grow, and seek their potential.

I will not leave my child unattended during any portion of the day until he is at least 12 years of age, and then will make the school aware of any situation requiring the child to be alone. As a family, we will devise a plan to be sure our child is safe and well cared for.

I understand that Life Academy is providing a home education framework as a Christian ministry of Life Church of the Assemblies of God. My family's enrollment and participation with the school is voluntary, and may be terminated by either party.

I understand that my actions reflect upon the school and church, and may impact the school and other enrolled families in ways in ways that I cannot foresee. Therefore, I will consult Life Academy to discuss withdrawing before seeking enrollment in another school. I will not initiate contact with any public school, its affiliate, or a social service organization without first contacting the school. Furthermore, I will notify the school of any contact initiated by a public school, its affiliate or representative, or law enforcement agency or social service organization regarding our family situation and/or homeschooling. I understand that failure to do so will jeopardize my continued enrollment.

I understand that my home is becoming a satellite classroom of the school, and as such, I agree to maintain basic living standards. I will keep my contract information current with the school, including address, telephone number, and email address. I understand that should the school become unable to contact me at the provided information my enrollment will be terminated.

I understand that violations of the law by me or my child will be grounds for termination for enrollment. Furthermore, acts of social or moral turpitude by me, my children, or any other member of the immediate family or household, will be grounds for immediate termination of enrollment as well.

I understand that Life Academy is not a legal organization, and does not provide legal representation nor retain an attorney on my or my child's behalf. I hereby release Life Academy, its staff and volunteers, from any and all legal responsibility in the educational outcome of my children enrolled in this school.

I understand that tuition is due in full upon admission, and is not refundable in part or whole. I understand that a transcript will not be issued for a partial semester, and will require a fee and 10 days notice to be prepared. Transcripts will not be issued if I fail to submit required progress reports in a timely manner, and will not be issued until I withdraw the child from our school.
